Dear Study Abroad Advocate,

Since 2010, the Fund for Education Abroad (FEA) has worked to make study abroad more accessible and inclusive through the provision of game-changing scholarships. We enclose the 2024-2025 scholarship flyer for you to share with your students who wish to study abroad during Spring 2024, Summer 2024, Fall 2024 or Academic Year 2024-2025.

FEA scholarships are awarded to students with financial need with a preference for underrepresented students. Of our scholarship recipients, 74 percent are first-generation college students, 84 percent identify as people of color, and 36 percent are community college students.

It's been a busy year for FEA! In Spring 2023, we reached a milestone of having supported more than 1,000 students through more than \$3 million in funding. We recently welcomed Quiamony Gaskins as our new Program Manager. We've also made some updates to our application: we have removed the letter of recommendation as an application requirement, and we changed our deadlines to allow students more time to apply for our scholarships.

- Receiving college credit at your home institution for the program abroad
